A few policy changes were put into place for the coming season. First if you must leave the park before your check out day that is fine but if you want a refund you need to go to the gatehouse the day you leave to get the refund. Our system cannot hold refunds for your next visit. This means if you don't go in and get your refund that day you lose the refund.

We seem to have had more violations for fireworks in the park. Fireworks are not only against Cutty's rules but are against Iowa law. These fireworks pose a safety hazard to everyone in the park. A wayward bottle rocket or roman candle that lands on an awning can cause a fire. Members sleeping in their camper could be hurt or even lose their lives to this hazard. This has happened in other campgrounds and we do not want it to happen here. A fireworks violation from security is grounds for immediate suspension from the park. If you are caught lighting off fireworks you will need to pack up and leave immediately.

As always there are many rumors going around the campground. If you hear something that upset, you or just doesn't seem right feel free to call me or Jim Anderson for clarification.

Example 1: A member came to the office wanting to know why we were getting rid of all seasonal sites over the next two years and turning them into open camping. We assured the individual that what they heard was not true. We also explained that any member can go to the Members Only web site, read the minutes from this year and see that the Board never even discussed this proposal.

Example #2: A member reading the minutes sees that the Board voted to hire an interim manager for 18 months and gave him many duties to perform. The member then asks in August why we still have two managers. The simple answer is if that member would have taken the time to get
