Recommended by Management: My recommendation would be to move all the money to West Bank. Put \$300,000 in a 6-month CD and see what interest rates would be to renew at the end of the term. If they are close to 3.5%, we put it back in the MM. If there is a higher interest rate, we cycle it again for another 6 months. This would leave approximately \$750,000 liquid plus the Vision checking balance of \$204,814 as of 6/13/24.

Dog wash installed. Ordered new LED lights with timer for tennis/basketball courts. Gearing up for the Fourth holiday: parking passes ordered and baseball club to handle parking again this year. No new updates on Splash Pad except confirmed the Slash Pad company will begin install June 30^{th.} Geese have been a problem this year and staff continue to work to push them off the property. From Club Hall meetings: contacted the Sheriff's department and they to make more drive through patrols. Investigating fans for Main Street. We have 2-3 cleanings each day on all bathrooms and have had no problems no need for additional patrols. We have camera systems in the Gate house, Clubhouse and in the Store, no need to add additional cameras currently. Getting bids to replace the roof on Main Street for next year. Two-tiered site fees to be considered for next year's budget.
