Question on how season is going. Revenue wise is up. Camping days down a little. Only 2 memberships that are non-income producing. Recently had the highest electrical monthly bill.

Any more thoughts on the wash out over the bridge. Travis has someone he is discussing the issue and reviewing solutions. Also review the incoming side of the tubes and washout starting. Spillway has some wash out as well, 2 loads of crushed concrete to fill the void. Still under investigation at this point in time.

Noticing more dead trees, any plans for solution? Like to get a lift to cut down trees ourselves this fall. Some tree work would have to be sub contracted out.

Chairs for the clubhouse. Still have a chair that we are using as a test chair.

Contractor still has some work to do; how much money do we still owe them? The contractor has not shared with us remaining balance. The work the contractor did at main street around the stage was no charge. Windows to be replaced in the event center, they came with cracked frames.

At the club hall meeting, a member brought forward an idea for a RC car track located behind the store. We checked with the insurance company to review idea. They had no concern with the idea. Dirt track, fencing and gates, table for cars, bleachers, water available are all ideas to consider. Open during café hours. Details to be worked out including rules.

Spooktacular parking. No luck with contractor to find enough people to assist with parking. It would have to be done by us. Discussing hours for trick or treat times. Concerns with people driving during this time. How do we address the cars driving around during this time. Add instruction on the app saying no driving cars not to be used for trick or treating during this time, and having park rangers enforcing. Email as well. Safety is top priority.
